Criminal Justice Reform: Prosecutorial Misconduct and Police Reform

Currently, when state prosecutors violate their own rules, there are no consequences. Vulnerable communities, in particular, have struggled to either place their trust in police departments or police oversight agencies that investigate allegations of misconduct. Unfortunately, people who are wrongfully accused, prosecuted and convicted of a crime, along with defense attorneys, elected officials, and the general public have no forum to request a confidential, independent investigation of alleged prosecutorial misconduct.

This workshop will focus on the different forms of misconduct and how the proposed New York State Commission on Prosecutorial Conduct will provide accountability for the most powerful players in the criminal justice system.

The Voting Rights Act, Voting Laws, and Early Voting - Continuing Legal Education (CLE)

Homeownership State of Blacks and Hispanics

The hollowing out of New York City's middle class makes it hard to afford rising housing costs and seniors are particularly vulnerable. They often turn to reverse mortgages as a last resort to stay in their homes. Reverse mortgage foreclosure and deed theft are on the rise, and homeowners need tools to fight back.

Keeping the Promise to End HIV/AIDS

According to the Centers for Disease Control and Prevention (CDC), African Americans represent 12% of the population, but account for 44% (17,528) of HIV diagnosis. African Americans have the highest rate of HIV diagnoses compared to other races and ethnicities (CDC, 2016). Hispanics/Latinos represent 18% of the population, but account for 25% (9,766) of HIV diagnoses. While the overall incidence rate in New York has decreased in the past few years, particularly due to New York State's plan to End the Epidemic by 2020, new infections remain concentrated among persons of color.

This workshop will focus on the following topics: engaging community stakeholders, faith leaders and elected officials on the relationships between mental health, drug use, and HIV incidence; the importance of the New York State plan to End the Epidemic by 2020; reducing the stigma in accessing mental health services in communities of color; enacting supportive legislation for affordable and stable housing for trans-persons of color; and providing additional resources needed to end the HIV epidemic by 2020.

MWBE City & State Agencies and Authorities Opportunities and Best Practices
